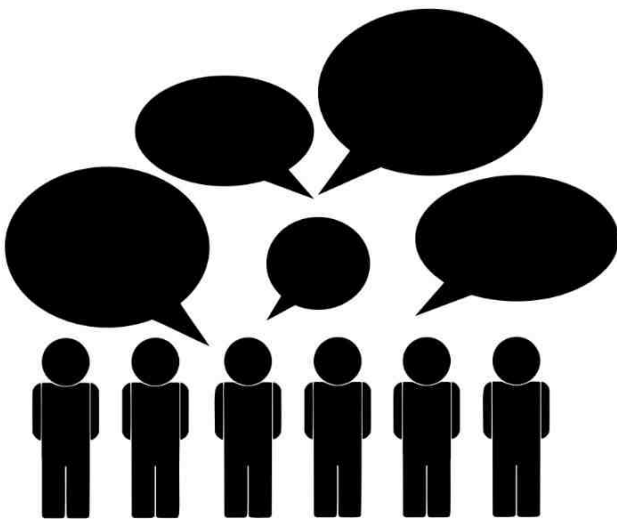
## OBJECTIVE OF THE CONFERENCE

## **FORMATTING AND SUBMISSION GUIDELINES**

- The abstract of 300 words should be sent. It shall include title of the paper, keywords, brief profile of the author/s indicating his/her email ID, contact number, designation, and official address.
- The word limit for a full paper along with an abstract is 3000-5000 words (excluding footnotes) submitted in MS Word Format.
- Research paper shall be the original and unpublished work of the author. Co-authorship is permitted to maximum two authors
- It must be typed in Times New Roman Font Size 12 on A4 size paper with 1” margin on all sides with 1.5 line spacing. All footnotes must be in Font “Times New Roman”, font size 10 with 1 line spacing.
- For footnotes and bibliography, the author(s) are required to follow the Bluebook: A Uniform System of Citation.
- The full paper shall be submitted in soft copy form.
- E-Certificates will be given to all the registered Participants.
- Selected Papers will be published in a book with E-ISSN Number
