Important Guidelines for the Admission of LL.M. (2 Years Course)-

- ❖ **Admission Criteria:** Admission for the LL.M. (2 Years Course) A.Y. 2023-24 will be completely on the basis of merit of the LL.M. Common Entrance Test (CET) Examination and **after the scrutiny of all required documents (offline mode) by the Admission Committee of the College.**
- ❖ **Reservation Policy:** The College has 51% of seats reserved for the **Hindi Linguistic Minority**. Those students who wish to apply under this category will be required to submit any document mentioned herewith - Birth Certificate or School Leaving Certificate or a notarized Affidavit stating that- "**Candidate belongs to Hindi Linguistic Minority and Mother Tongue is Hindi**".
- ❖ **Mode of Admission:** The Online admission link will be provided by the college for filling the online admission form. The fees for the academic year will be accepted online **ONLY** after the final verification of all required documents.
- ❖ **Cancellation Policy-** In case of admission cancellation, the student must submit an application through mail to the college email address ([hvpsllm20@gmail.com](mailto:hvpsllm20@gmail.com)) before the 30<sup>th</sup> of September 2023( S a t u r d a y ). The candidates who cancel their admission through the above-mentioned process will get a refund of fees paid only by cheque within **thirty working days after deducting Rs. 1000 as admission processing charges**. The cheque will be in the name of the Student/Parent. The cheque needs to be collected physically during the college working hours i.e. 10:00 AM to 4:00 PM. Post-cancellation requests for reconsideration of admission shall not be entertained in any case.
