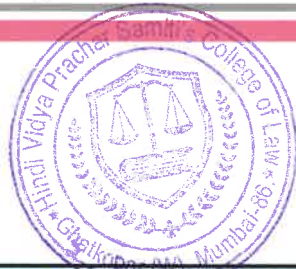

VidhiTaksh Law Fest Covid-19 Instructions:

The covid-19 instructions for VidhiTaksh Law Fest are as follows -

Fest Venue

1.) Gap between individuals should be maintained as per GOI guidelines.

2.) Candidates need to maintain a space of at least 2-3 feet from each other at all the time.

3.) Temperature of the candidates to be checked at the entry point/s using Contact-less Forehead Thermometer. In case, any candidate has a high body temperature, he/she should be disqualified or sent home.

4.) The candidate should carry his/her 3-ply mask, and should keep it on all the time.

5.) The participants should carry their own Sanitizers and keep sanitizing their hands every two hours.
