Report on Students and Faculty Exchange Program

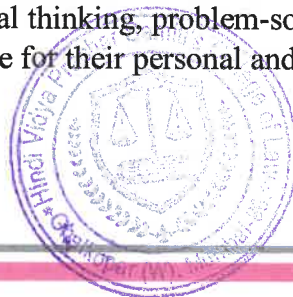




