INSTITUTIONAL POLICY FOR INCLUSION OF PERSONS WITH DISABILITIES

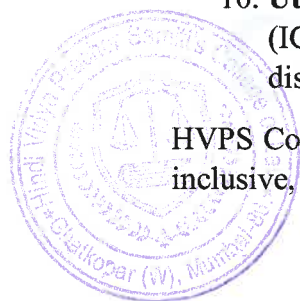
