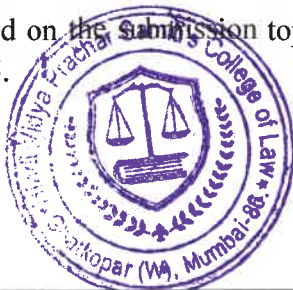
NOTICE FOR ASSIGNMENT & PPT TO 3rd Year LLB (Sem VI) & FY. LLB (SEM II) STUDENTS
