CIRCULAR:-

Attention of all the Principals of the Affiliated Colleges, Directors of the Recognized Institutions and the Head, University Departments is invited to this office Circular No. AAMS_UGS/ICC/2025-26/11 dated 24th April, 2025 relating to the Equivalence for LL.B. (3years) and LL.B. (5years).

They are hereby informed that the recommendations made by the Board of Deans at its meeting held on 11th August, 2024 have been accepted by the Academic Council at its meeting held on 19th August, 2025 vide item No. 9.10 and that in accordance therewith the Law Clarification and Equivalence Notification for LL.B. (3years) and B.A. LL.B. (5years) Law Courses was approved with effect from the academic year 2025-26.

Clarification and Equivalence Notification.

For LL.B. (3 Years) and B.A. LL.B. (5 Years) Law Courses

Subject: Equivalence of Courses/Papers under Revised Syllabi of LL.B. 3 Years and B.A. LL.B. 5 Years Programs.

Preamble:

In light of the syllabus revision undertaken from the academic year 2022–2023, and subsequent changes in certain papers/courses under the LL.B. (3 Years) and B.A. LL.B. (5 Years) programs, this notification is issued to provide necessary clarification. The objective is to remove any ambiguity regarding course equivalence and ensure clarity concerning the teaching and evaluation of certain subjects especially where course titles and content have changed or appear in different semesters across the old and new syllabi.

This notification is issued with reference to the earlier circular No. AAMS/UGS/ICC/2025-26/1 dated 1st April 2025, which had given rise to confusion regarding subjects like Taxation Law, Alternative Dispute Resolution (ADR), and Labour and Industrial Relations Code II in the B.A. LL.B. (5 Years) course.

Clarification Note:

1. Semester IX – B.A. LL.B. (5 Years), 60:40 Pattern, Academic Year 2025–26:

The subject Interpretation of Statutes (IOS) shall be taught.

The subject Labour and Industrial Relations Paper II shall not be taught in Semester IX of the 5-year course.

However, for LL.B. (3 Years), 75:25 pattern, Labour and Industrial Relations Code II shall continue to be taught as prescribed.

2. Semester X – B.A. LL.B. (5 Years), 60:40 Pattern, Academic Year 2025–26:

The subject Alternative Dispute Resolution (ADR) shall be taught as a compulsory paper.

The subject Taxation Law shall not be taught as a compulsory paper in this semester.

3. Pattern of Evaluation:

The evaluation for the B.A. LL.B. (5 Years) program for the academic year 2025–26 will be conducted as per the 60:40 pattern in accordance with the old syllabus.

4. Applicability of Old Syllabus:

All subjects for Semester IX and Semester X of the B.A. LL.B. (5 Years) course for the academic year 2025–26 shall be taught strictly as per the old syllabus (60:40 pattern).

This notification does not imply early implementation of the new CBCS (75:25) syllabus for the final year of the 5-year course.

5. Clarification on Syllabus Implementation:

One batch of LL.B. (3 Years) has successfully completed the program under the new CBCS 75:25 pattern.

However, the B.A. LL.B. (5 Years) course will enter its 4th year under the CBCS 75:25 from the academic year 2025–26.

The 5th Year (i.e., final year) students of the B.A. LL.B. (5 Years) program will continue and complete their course under the old 60:40 syllabus applicable for the Academic year 2025–26.

Conclusion:

This notification is issued solely to clarify equivalence and curriculum applicability. It shall
