**Instructions for Preparing the Draft**

**1. Format & Length**

- a. Draft may be **typed** (Times New Roman, Font Size 12, 1.5 line spacing, justified alignment).

**2. Content Requirements**

- a. Introduction (Background / Relevance of the Topic)
- b. Issues / Questions involved
- c. Explanation with **relevant case laws** and statutory provisions
- d. Arguments / Critical analysis
- e. Conclusion & Suggestions
- f. Bibliography / References (Books, Bare Acts, Articles, Case laws, Online sources)

**3. Structure of the Draft**

- a. **Cover Page** with all required details.
- b. **Index / Table of Contents** with proper page numbering.
- c. Proper **headings and sub-headings** throughout.
- d. Sequential **page numbering.**

**4. Citation & References**

- a. Use **footnotes** for case laws and references.
- b. Follow a consistent citation style.
- c. Plagiarism will not be tolerated; proper acknowledgement of sources is compulsory.

**5. Submission**

- a. **Date of Submission:** 17th October, 2025, at 9:00am



## Specific Requirements for Drafts

### 1. Draft Public Interest Litigation (PIL)

- Must be in the **format of a legal petition.**
- Include:
  1. **Title** (In the High Court / Supreme Court of India)
  2. **Parties to the Petition** (Petitioner vs. Respondent)
  3. **Introduction & Locus Standi** (who is filing and why)
  4. **Facts of the Case**
  5. **Grounds / Issues Raised**
  6. **Relevant Constitutional Provisions & Case Laws**
  7. **Prayer / Reliefs Sought**
- Language should be **formal and precise.**

### 2. Draft Bill

- Must follow the **legislative format.**
- Include:
  1. **Title of the Bill**
  2. **Preamble / Statement of Objects & Reasons**
  3. **Definitions** (if necessary)
  4. **Sections & Clauses** (clearly numbered and structured)
  5. **Applicability / Scope**
  6. **Penalties, Offences, and Procedures** (if applicable)
  7. **Repeal & Savings** (if replacing earlier law)
- The draft must resemble an **official legislative document.**

### 3. Draft Amendment

- Clearly state:
  1. **Existing Provision** (Article / Section / Clause)
  2. **Proposed Amendment** (precise wording of the change)
  3. **Justification / Rationale** for amendment
  4. **Expected Impact** (legal, social, administrative)
- Should be concise but legally sound.

### 4. Policy Paper

- Must follow **academic-policy format.**
- Include:
  1. **Title of the Policy**
  2. **Executive Summary** (one-page overview)
  3. **Background / Problem Statement**
  4. **Objectives of the Policy**
  5. **Policy Provisions / Proposed Measures**
  6. **Implementation Strategy**
  7. **Expected Outcomes**
  8. **Case Laws, Reports, and Data Support**
  9. **Conclusion & Recommendations**
- Should be **analytical and research-based** with citations.
